OFFICIAL CONTEST RULES

WALK 97.5 hereinafter referred to as the "Station"

No purchase or payment is necessary to enter or win this promotion. A purchase or payment of any kind will not increase your chances of winning. By participating, each entrant fully and unconditionally agrees to be bound by and accepts these official Contest Rules.

1. Promotion Dates

The Station, owned and/or operated by Connoisseur Media, LLC (CONNCOS) is running a station or multi-station promotional contest (the "Contest") beginning on or about August 12, 2024 at 12:00 am EDT and ending on or about September 8, 2024 at 11:59pm EDT (the "Promotion Dates"). Grand Prize winner or winners will be announced on or about September 12, 2024.

2. Entry / How To Win

- a. Potential qualifiers will listen to WALK-FM 97.5 during the "contest" promotional period and listen for the codeword announcement around 10:00am, 1:00PM and 4:00PM every weekday throughout the contest period.
- b. When the codeword is announced, that is the prompt to test that specific word for that specific announcement to 631-955-9750. Each correct codeword texted will be qualified to win! (One Text per person per codeword will be a valid entry)
- c. concealed or hidden which against it or any of it, they have had, may have had or now have, or which any of their heirs, representatives and/or assigns hereafter can, shall or may have for or by reason of any matter, cause or thing whatsoever, including but not in any respect limiting the generality of the foregoing, any and all claims which or might have asserted relating to this contest, and agrees to deliver an executed release form at the time of delivery of any prize(s).
