

WALK-FM CRUISE PROMOTION DECEMBER 2024

OFFICIAL CONTEST RULES

Connoisseur Media Long Island (WALK 97.5 – WALK-FM, KJOY 98.3 – WKJY-FM, 103.1 The Wolf – WWWF-FM, 94.3 The Shark – WWSK-FM, 104.7 WHLI-FM and 1100 WHLI-AM) hereinafter referred to as the “Stations”

No purchase or payment is necessary to enter or win this promotion. A purchase or payment of any kind will not increase your chances of winning. By participating, each entrant fully and unconditionally agrees to be bound by and accepts these official Contest Rules.

1. Promotion Dates

The Stations, all owned and/or operated by Connoisseur Media, LLC (CONNCO) are running a multi-station or single station promotional contest (the “Contest”) from on or about December 26, 2024 at 12:00 am EDT which will end on or about January 10, 2025 at 11:59pm EDT (the “Promotion Dates”). The Grand Prize winner will be announced on or about January 13, 2025.

2. Entry / How To Win

- a. ***Potential qualifiers will listen to WALK 97.5 FM weekdays during the “contest” promotional period for the “KEYWORD” which will be announced 3 times per weekday during the contest promotional period. (Key words will be announced at around 10AM, 1PM and 4PM local time.)***
- b. ***When the “Keyword” is announced, potential qualifiers will be instructed to text the keyword to 631-955-9750***

This is not an additional path of entry. No entry will have better odds of winning. All Entries and physical entry form requests that go undelivered will be disqualified. Connoisseur Media Long Island is not responsible for entries or entry requests that are delayed and/or are delivered after the contesting period or entries or entry requests that go undelivered.***
- d. ***On or about January 13, 2025, Connoisseur Media Long Island Judges will choose a contestant by random draw from all eligible entries. The contestant will be notified via phone and will be awarded the Grand Prize.***

4. Winner Selection / Odds / Prizes

- a. *On or about January 13, 2024, Connoisseur Media Long Island Judges will choose a contestant by random draw from all eligible entries. The contestant will be notified via phone and will be awarded the grand prize.*
- b. *No one entry will have better odds of being selected.*
- c. *Odds of winning are based on number of entries received. Final odds of being selected the winner will only be calculable after the contest period ends and will be determined by the total number of eligible entries recorded during the contesting period.*
- d. *The entry selected as the winner will be notified via the phone number given at the time of qualification. If the contestant that submitted the selected entry is unable to be reached in a timely manner as decided by the station judges, another entry may be selected at random. Once connection with the contestant that submitted the selected qualifying entry is made and verified, the winner will receive the Grand Prize as described below in exhibit B.*

5. Acceptance and Delivery of Prize

If selected, the Grand Prize must be accepted as awarded as described below in exhibit B. The Grand Prize and all elements of the prize are non-transferable. 7. Release

Contest winners agree on their own behalf and on behalf of their heirs, successors, representatives and/or assigns, to fully and forever release and discharge CONNCOS and each and all of its subsidiary and affiliated corporations, companies and divisions, its predecessors, successors and assigns, and its respective directors, stockholders, officers, employees and agents, of and from any and all claims, demands, agreements, contracts, covenants, actions, suits, causes of action, obligations, controversies, debts, costs, expenses, accounts, damages, judgments, losses and liabilities of whatsoever kind or nature in law, equity or otherwise, whether known or unknown, whether or not concealed or hidden which against it or any of it, they have had, may have had or now have, or which any of their heirs, representatives and/or assigns hereafter can, shall or may have for or by reason of any matter, cause or thing whatsoever, including but not in any respect limiting the generality of the foregoing, any and all claims which or might have asserted relating to this contest, and agrees to deliver an executed release form at the time of delivery of any prize(s). If a minor is a contest winner, the person's parent or legal guardian must sign said release on the winner's behalf.

8. Indemnity

Disney Cruise Line Prize Description

Vacation Package shall consist of the following:

1. One (1) Seven (7)-night Disney Cruise Line vacation for winner and up to three (3) persons, to be taken aboard the Disney Treasure. The Vacation Package is subject to the conditions set forth below.

If winner resides outside a 250-mile radius of Port Canaveral:

- Ground transportation for up to Four (4) persons or voucher(s) for local transportation from the Arrival Airport to the hotel, from the hotel to Port Canaveral, and from Port Canaveral to the Arrival Airport (at the discretion of Disney);

One (1) Seven (7) night cruise on the Disney Treasure for up to Four (4) persons, consisting of:

- One (1) stateroom aboard the Disney Treasure (location/category at the discretion of Disney) with a maximum occupancy Four (4) people;
- All meals onboard the Disney Treasure (excluding specialty and fine dining);
- Pre-paid onboard gratuities for the stateroom host/hostess, dining room server, assistant server, and head server;
- Taxes, Fees, and Port Expenses (as defined on the Disney Cruise Line website)

All costs and expenses not expressly stated in the Vacation Package description above are excluded and solely the responsibility of winner or guests, including but not limited to:

- Travel insurance

- Vacation Package components may not be sold, traded, transferred, or refunded. Vacation Package is not redeemable for cash. Vacation Package is non-commissionable.
