

# **WALK 97.5's TRIP GIVEAWAY TO DREAMS RESORTS AND SPAS**

**OFFICIAL CONTEST RULES**  
WALK 97.5 hereinafter referred to as the "Station"

No purchase or payment is necessary to enter or win this promotion. A purchase or payment of any kind will not increase your chances of winning. By participating, each entrant fully and unconditionally agrees to be bound by and accepts these official Contest Rules.

## **1. Promotion Dates**

*The Station, owned and/or operated by Connoisseur Media, LLC (CONNCO) is running a station or multi-station promotional contest (the "Contest") beginning on or about January 14, 2025 at 12:00 am EDT and ending on or about February 7, 2025 at 11:59pm EDT (the "Promotion Dates"). Grand Prize winner or winners will be announced on or about April 3, 2023.*

## **2. Entry / How To Win**

- a. Potential qualifiers will listen to WALK-FM 97.5 during the "contest" promotional period and listen for the song of the hour announcement around 10:00am, 1:00PM and 4:00PM every weekday throughout the contest period.*
- b. When the song mentioned in that specific hour's announcement plays in its entirety within that particular hour, that is the prompt to call 631-955-9750. The 9<sup>th</sup> selected caller will be qualified to win the grand prize.*
- c. WALK judges will choose a contestant(s) by random draw from all eligible qualifiers. The contestant(s) will be notified via phone and will be awarded the grand prize.*
  - a. Odds of winning may vary depending on the number of qualifying entries received.*

## **4. Acceptance and Delivery of Prize**

*All prizes must be accepted as awarded. No Cash Value. All prizes are non-transferable. Inability to accept prizes or unwillingness to use prize or elements as delivered will result in forfeiture. Prize will be fulfilled by representatives or agents of Dreams Resorts and Spas. Prize description as well as restrictions, blackout dates and expiration dates are below in "Exhibit B". Additional restrictions may apply.*

## **5. Conditions / Eligibility**

**6. Release**

***Contest winners agree on their own behalf and on behalf of their heirs, successors, representatives and/or assigns, to fully and forever release and discharge CONNCOS and each and all of its subsidiary and affiliated corporations, companies and divisions, its predecessors, successors and assigns, and its respective directors, stockholders, officers, employees and agents, of and from any and all claims, demands, agreements, contracts, covenants, actions, suits, causes of action, obligations, controversies, debts, costs, expenses, accounts, damages, judgments, losses and liabilities of whatsoever kind or nature in law, equity or otherwise, whether known or unknown, whether or not concealed or hidden which against it or any of it, they have had, may have had or now have, or which any of their heirs, representatives and/or assigns hereafter can, shall or may have for or by reason of any matter, cause or thing whatsoever, including but not in any respect limiting the generality of the foregoing, any and all claims which or might***

*have asserted relating to this contest, and agrees to deliver an executed release form at the time of delivery of any prize(s). If a minor is a contest winner, the person's parent or legal guardian must sign said release on the winner's behalf.*

# EXHIBIT B

## Dreams Resorts & Spas Radio Remote Prizing Terms & Conditions 2025

On the behalf of Hyatt, JAWW Media & Marketing (The Travel Partner for WALK-FM) will provide:

- (1) One (1) prize consisting of four-day/three-night all-inclusive stay for two (2) adults and two (2) children age 17 and under to any one of the Dreams Resorts in a Premium Room Category listed below (“Dreams Resorts Accommodations”), with a maximum occupancy of two (2) adults and two (2) children age 17 and under with a \$2,000 airfare allotment (“Airfare”), ), plus an additional \$150 allotment toward airport transportation upon arrival and departure to and from the resort (“Airport Transportation”) , Dreams Resorts Accommodations, Airfare, and Airport Transportation collectively, the “Prize Package”).

1.1 Estimated Average Retail Value Accommodations = \$4,500

Airfare Allotment = \$2,000

Airport Transportation Allotment = \$150

Estimated Total Retail Value of accommodations and airfare allotment for four adults = **\$6,650** (“Prize Package”)

- (1) **Prize winner must be 21 years or older.**

- (2) The Prize Package includes:

- (i) Accommodations are valid for a premium room category and may vary based upon resort selection. Accommodation is valid for one room, maximum occupancy of two (2) adults and **two (2) children age 17 and under** and include all meals and alcoholic and non-alcoholic beverages that are available as part of the standard all-inclusive package. Additional room charges, spa services, telephone calls, incidentals including upgraded alcohol and experiences and all additional expenses are not included. Giveaway is only valid for the specific Dreams Resorts listed above based in Mexico or the Caribbean. The giveaway is not applicable to any resorts outside of those listed above.
